In the 1800s the challenges for Queensland families wanting to access medical treatment for their sick children were incomprehensible. The determination of one person, Mary McConnel, inspired the community and in 1878 the first children's hospital in Brisbane opened. In 1905 the hospital received the first recorded bequest of 15,000 pounds.

Where we are today

Queensland Children's Hospital helps thousands of sick and injured children each week, almost half of which arrive at the hospital from regional and rural areas. The hospital has been ranked the 15th best specialised paediatric hospital in the world, making it the leading children's hospital in the Southern Hemisphere.

Funding cystic fibrosis research for kids like Evie

When Evie was only four weeks old, she was diagnosed with cystic fibrosis (CF) – a life-threatening disorder that damages the lungs and digestive system.

Her CF has led to ongoing infections in her lungs, which has resulted in severe lung damage and hampered Evie's ability to maintain a normal developmental weight for her age group. She is expected to require a double lung transplant in the future. However, her team are working tirelessly to prolong this procedure with admissions and treatment. In early 2021, her family received news that Evie had access to Trikafta – a revolutionary drug used to treat CF. This drug has been instrumental in her wellbeing.

To receive treatment at Queensland Children's Hospital, she often spends four to six weeks admitted as an inpatient.



This means anxious time away from her family, friends and animals at her home in Chinchilla. During treatment Evie's lungs need to be kept clear with IV antibiotics. She must take multiple medications and attend intense physio sessions twice a day. She has three inhalers per day, each taking up to 30 minutes, along with her vibration vest.

These admissions are broken up with short stints at home to recoup and mentally prepare for the next admission. This is hard on Evie, her parents and her siblings. The Children's Hospital Foundation has pledged \$2.5 million over five years towards Queensland's first dedicated cystic fibrosis research program to help improve outcomes for children living with the life limiting condition, just like Evie.



Thanks to Children's Hospital Foundation supporters, we've proudly been funding leading CF researchers including Professors Claire Wainwright, Peter Sly and Scott Bell's research into the disease over the past decade. Children like Evie will benefit from the findings and advances that are discovered through the funding of this vital research program.

A baby is born with CF in Australia every four days, with around 265 children being treated for the condition at Queensland Children's Hospital annually. Research strives to deliver improved health outcomes, better quality of life and longer life expectancy for all of these children.

Because of this ground-breaking research, there are now more adults than children living with CF right across the world. However, there is still much to be discovered as there is still no cure.

"At the age of 2, my daughter Amber was involved in a car crash which left her with severe head injuries and a lifetime disability. She spent over three months in the Children's Hospital in Brisbane, as well as countless outpatient visits over the following few years.

My daughter is now 35 years old and is living her best life thanks to the amazing doctors and nurses and the support of the Foundation. I am grateful every day to still have her in my life.

I will never know the people who generously donated to the Foundation to provide my daughter with lifesaving equipment and well-trained staff, but they helped save her so I could enjoy a lifetime with her. It gives me a sense of peace and contentment to know that I have completed the 'pay it forward' cycle and that my life has benefitted others," says Cheryl. Geoff Carrick lived on a cattle station 'Maitland' located at Einasleigh, approximately two hours' drive north of Charters Towers.

Although Geoff never had any children himself, he strongly believed "no child deserved to be sick as they had not yet had a chance to live their life".

It was this belief that led Geoff to leave a substantial gift to the Children's Hospital Foundation in his Will.

When Geoff passed away in 2018 his generous gift was used to fund research into immunotherapy, brain cancer and cystic fibrosis. It also helped fund state-ofthe-art 3D surgical navigation equipment and a Digital PET-CT scanner, making Queensland Children's Hospital the first paediatric hospital in Australia to offer this cutting-edge digital technology.

Suggested wording for a gift to Children's Hospital Foundation

Your solicitor may find the following wording helpful:

A specific or monetary gift

I give **[insert particulars of the specific asset or sum of money being given]** to CHILDREN'S HOSPITAL FOUNDATION ABN 116 079026 87 ("the Charity") for its general purposes.

A residuary gift

I give [insert either "all of my residuary Estate" or "the fraction or percentage of your residuary Estate that you would like to give"] to CHILDREN'S HOSPITAL FOUNDATION ABN 116 079026 87 ("the Charity") for its general purposes.

Declaration

Following the inclusion of your nominated gift to the Children's Hospital Foundation, please also include the following declaration:

"In relation to this gift, I declare as follows:

- a. a general charitable intent shall apply;
- b. a receipt signed by the Chief Finance Officer for the time being or another person authorised by the Charity shall constitute a full and sufficient discharge to my executors;
- c. my executors are not obliged to see or enquire into the application of the gift so made by me;
- d. if the Charity has amalgamated with another institution, society or body of persons or changed its name before my death, the benefit intended to be given by the gift shall be paid and/or transferred to the institution, society or body of persons existing at the date of my death as a result of such amalgamation or change of name. If the Charity is found to have ceased to exist before my death or the gift made by me otherwise fails for whatever reason, the benefit intended to be given by the gift shall be paid and/ or transferred to such charity or charities and if more than one in such shares as my executors in their absolute discretion shall think fit and I express the wish that in so doing, my executors shall seek to benefit a charity or charities as close as possible in purpose to that intended to be benefited by the original gift made by me."
